### TO RENT

Upon request, a rental contract will be sent to you. Simply fill it out completely (a major credit card is required), sign it, and return it along with payment for the session's rent. An instrument will be reserved for you upon receipt of your payment and rental contract. The instrument can be picked up at the Robertson & Sons booth in the UNM Student Union Building, *Cochiti Room*, on the first day of the session. The instrument must be returned on or before the last day of the session or immediately following the final concert. Instruments may also be delivered to our shop at 3201 Carlisle Blvd. NE.

Intermediate Cellos, all sizes - \$75.00/week

\*All rentals include a bow, case, and rosin.

Any instrument that is not returned at the end of the New Mexico Suzuki Institute must be delivered or shipped back to Robertson & Sons Violin Shop at the expense of the renter via Federal Express or UPS, prepaid and insured for full value. **4. Terms:** The terms "I," "me," "my" refer to the person(s) who sign this agreement. The terms "you" or "your" refer to Robertson & sons Violin shop Incorporated.

**5. Rent of Instrument:** I rent from you, on the terms and conditions of this agreement, the musical instrument(s) described in paragraph 3, or on an attached addendum to this agreement, for one week-long session at the rental fee indicated in paragraph 3 or otherwise invoiced by you to me. Such instrument(s), together with the bow(s) and case(s) provided, are referred to in this agreement as the "Instrument." I understand that I may, with your approval, return the Instrument in exchange for a replacement Instrument of the same or a different value and with the same or a different rental fee. If the Instrument is exchanged for a replacement, the term Instrument shall refer to such replacement Instrument as well as any Instrument retained by me together with the case and bow provided. In connection with such exchange, I will sign any addendum to this agreement requested by you. I agree to return the rental instrument immediately after the final concert.

**6. Payment Terms:** I will pay you the rental fee, plus applicable taxes, in advance. I agree that this amount is due whether or not I receive an invoice from you. In the case that I continue to rent beyond New Mexico Suzuki Institute 2010, I elect the payment method selected below (initial one):

**7. Inspection; Maintenance; Loss; Damage and Repairs:** Prior to renting, I have inspected the Instrument and agree that it is in good playing condition. I will keep the Instrument in the same condition as at the beginning of the rental. I will pay the cost of all maintenance of the Instrument, whether by fire, flood, Act of God, theft, vandalism, neglect, accident or any other cause. I will notify you immediately of any loss or damage and will arrange only for you to make any repairs. I will not attempt to make any repairs or allow any other person to attempt such repairs. I am responsible for any costs or damage associated with unauthorized repairs.

**8. Insurance:** I understand that you do not have any insurance covering the Instrument. Should any damage occur to the Instrument, bow or case during the rental period, I agree to pay for the cost of the repairs before the end of the New Mexico Suzuki Institute

**9. Shipping:** I will pay all charges for shipping the Instrument to or from you in the case that the Instrument is not returned after the final concert.
